

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.power-guru.com>, and Power Guru Solar Energy LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Power Guru Solar Energy LLC include <https://www.power-guru.com> and Power Guru. By using the Power Guru website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Power Guru may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.
